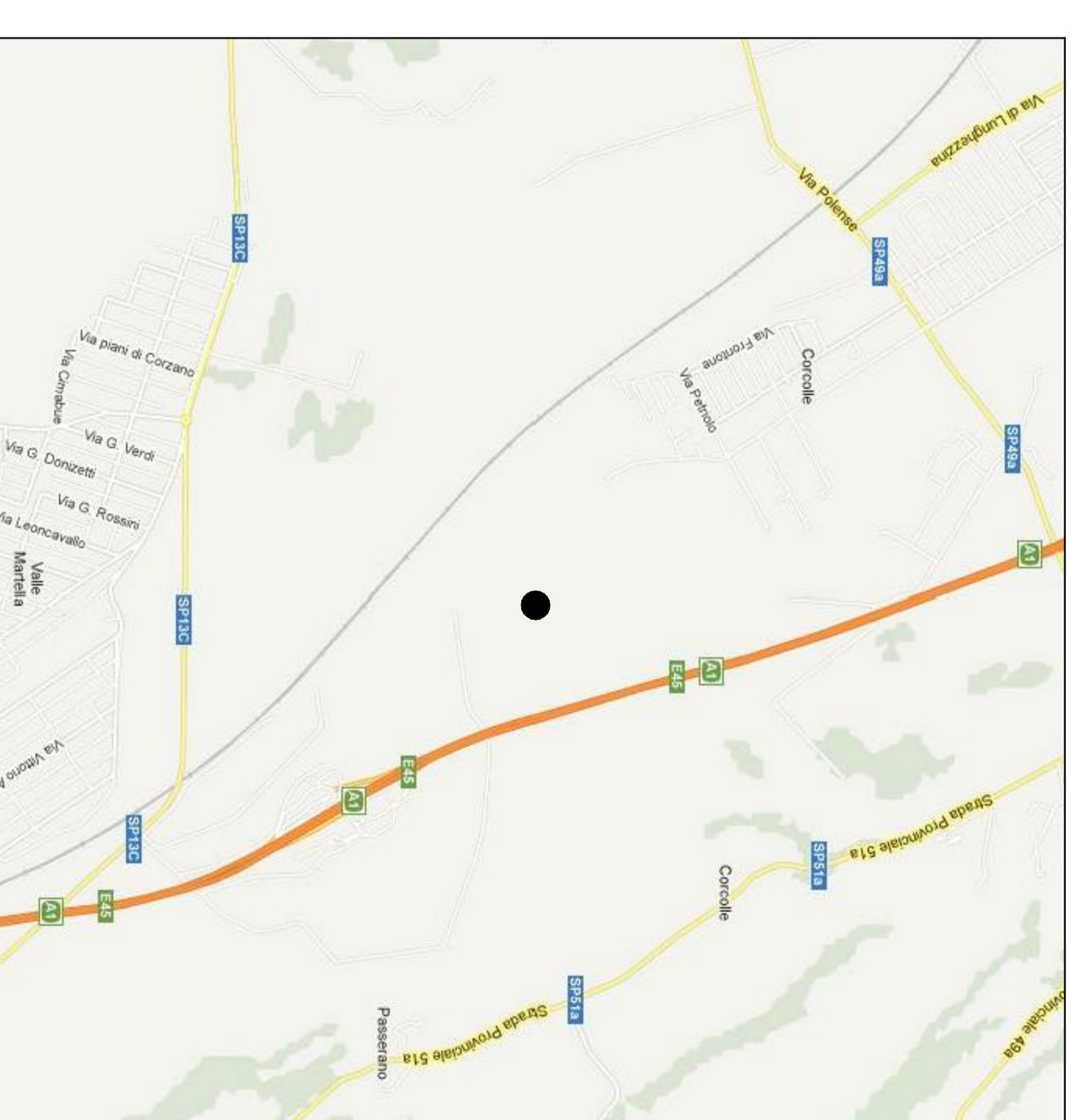

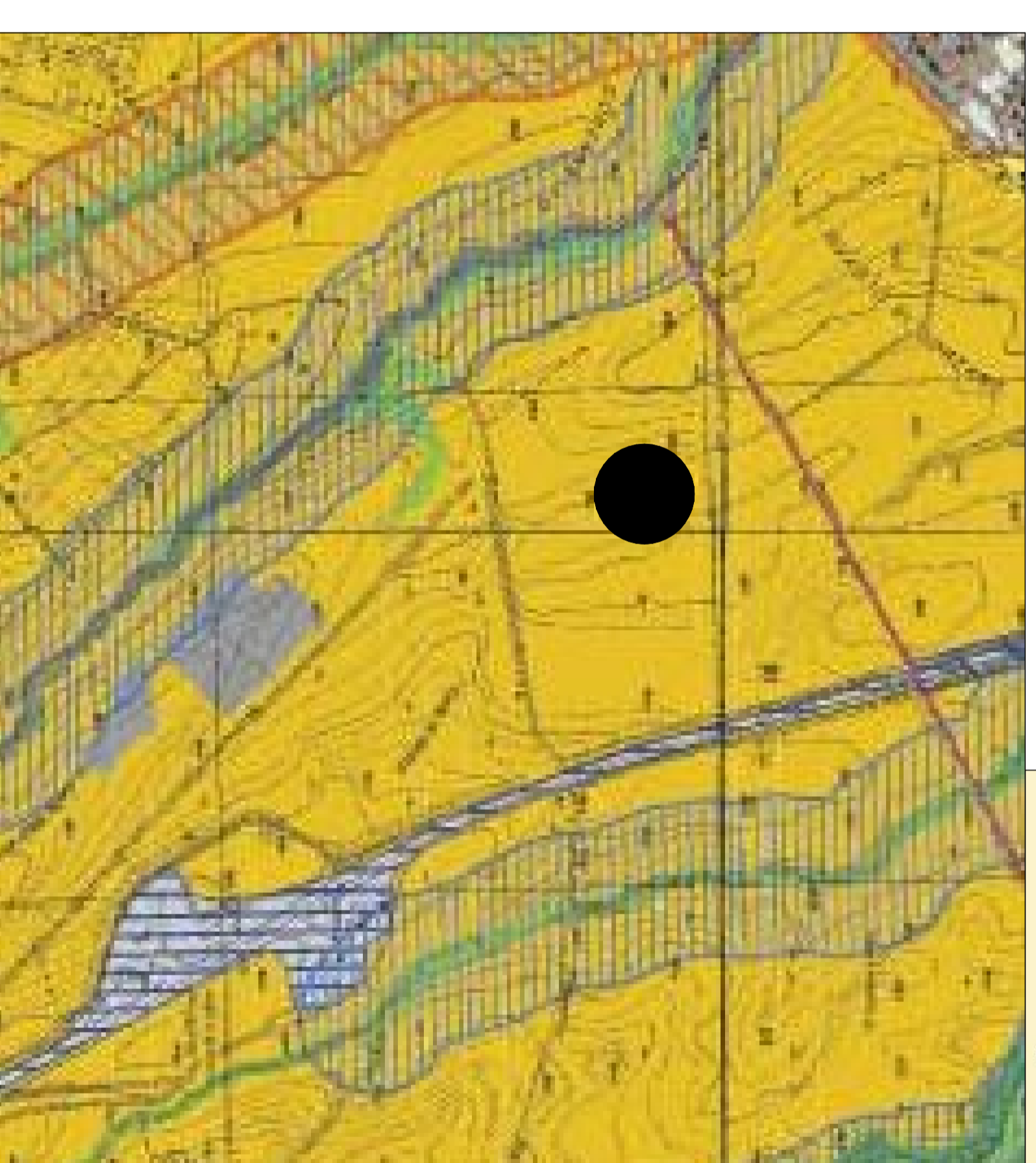

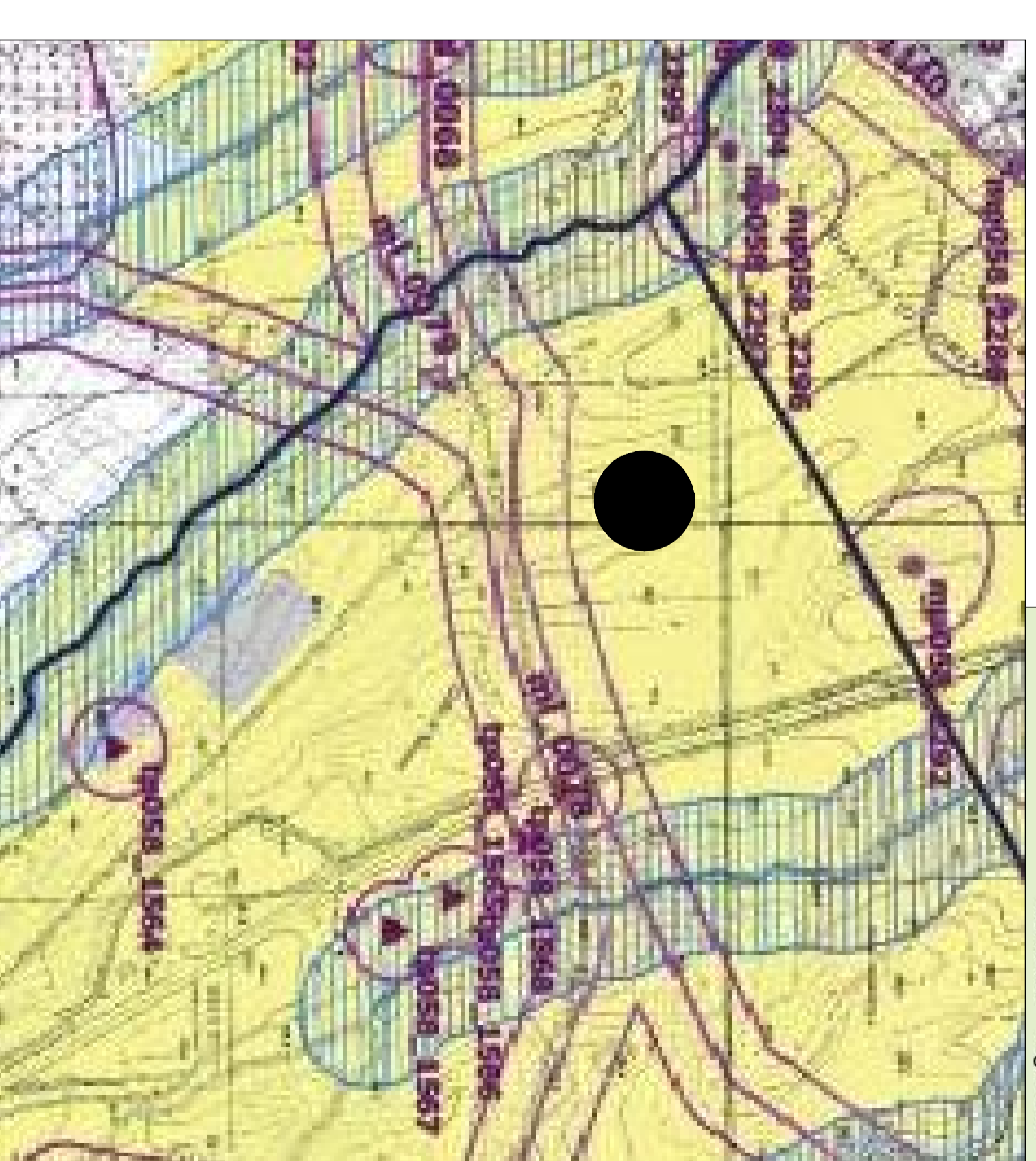
INDIVIDUAZIONE AREA
